## Trainer's Passkey Application and Guidelines

1. Passkeys are available to current members at fees set by the Board and shall be revoked by the Board if Club Guidelines are not respected.
2. Passkey fees are payable to Go Dogs! quarterly, due on the 1st and delinquent on the 10th of January, April, July, and October.
3. Fees may be hand delivered to the Trainer's Passkey Coordinator, mailed, or placed into the check box at Go Dogs! Cash passkey fees are to be **hand delivered** to the Trainer's Passkey Coordinator. Cash fees are **NOT** to be mailed.
4. Members who receive Class Instructor Coupons may pay for their individual, or family, Trainer's Passkey quarterly with one coupon and \$1 fee. The late fee of \$20 applies to members remitting a coupon after the delinquency date.
5. A late charge of \$20 will be added to delinquent payments. The Trainer's Passkey will be revoked and must be turned into the Trainer's Passkey Coordinator promptly if all fees (regular and late) are not paid by the end of that month. Any member who has passkey privileges revoked for failing to pay quarterly fees within 30 days of the due date shall not receive another passkey for 6 months from the date of privilege revocation. Delinquent fees must be given directly to the Trainer's Passkey Coordinator, as opposed to mailing, unless other arrangements are mutually agreed upon.
6. Acceptance of a passkey is a commitment to pay fees for the quarter, in advance.
7. A 10% discount is available for annual prepayment of Trainer's Passkey fees.
8. Passkeys are not to be copied or loaned. Lost keys must be reported promptly, and a \$5 fee will be charged for a new key.
9. Passkey holders must be 18 years of age. Minors requesting the trainer's pass must belong to the club on a family membership and may get a trainer's pass without a key. An adult member with a Trainer's Passkey must accompany the minor whenever the minor is using club facilities.
10. Passkey holders are responsible for any guests they bring to the club. Guests may not bring dogs into the building, except as provided in Facility Use Guidelines.
11. At least one ring will be made available to passkey holders seven days per week from 6:30 a.m. to 10:30 p.m., except during scheduled obedience, flyball, agility, conformation, matches, demos, meetings, other special events and cleaning times.
12. All Facility Use and Club Guidelines also apply.
